



Dear Guest,

We look forward to welcoming you to the Hotel Daniel Vienna shortly and would like to inform you about the current COVID-19 prevention concept.

One of the following proofs is mandatory upon arrival:

- **Valid negative test result:**
  - Negative PCR test** (validity: 48 hours)
  - Negative antigen test** from test street, pharmacy, etc. (validity: 24 hours)
  - Compulsory test for children from 6 years
  
- **Vaccination certificate** When two doses of a vaccine are necessary (BioNTech/Pfizer, Moderna, AstraZeneca), the vaccination certificate is valid from the date of the second dose, whereas in the case of Janssen/Johnson&Johnson the vaccination certificate is valid from the 22nd day after the vaccination was received. In the case of persons who have recovered and only receive one dose, the vaccination certificate is valid immediately from the date of the vaccination.  
The vaccination certificate is valid for 270 days.  
Proof of vaccination certificate, vaccination card or the digital green passport
  
- **Proof of recovery** through separation notice, antigen test or proof of recovery status

Please note that the tests have to be renewed after the respective validity has expired. Valid access tests are also required in all restaurants, cafés and bars.

**PCR tests** can be carried out in the nearby Novogenia laboratory at Kärntner Straße 51, 1010 Vienna. You will usually receive test results within 24 hours. **Antigen tests** are carried out in pharmacies and the test streets of the City of Vienna. The closest drive in Test Street is next to the “Ernst Happel Stadion” Meiereistraße 7, 1020 Wien. Please register prior on: <https://coronavirus.wien.gv.at/teststrasse-stadion/>. The closest pharmacy is available within 5 minutes walking distance. Fasanapotheke, Hohlweggasse 21, 1030 Wien. Alternate you may register on the website: [www.allesgurgelt.at](http://www.allesgurgelt.at) and get tested at the BIPA drug stores. Please ask our reception for directions and further information.
