

# GRAND HÔTEL WIESLER

Dear Guest,

We look forward to welcoming you to the Grand Hôtel Wiesler shortly and would like to inform you about the current COVID-19 prevention concept.

One of the following proofs is mandatory upon arrival:

- **Valid negative test result:**
  - Negative PCR test** (validity: 3 days)
  - Negative antigen test** from test street, pharmacy, etc. (validity: 2 days)
  - Antigen self-tests** – recorded digitally in an official data processing system – (validity: 1 day)
  - Compulsory test for children from 12 years
- **Vaccination certificate** When two doses of a vaccine are necessary (BioNTech/Pfizer, Moderna, AstraZeneca), the vaccination certificate is valid from the date of the second dose, whereas in the case of Janssen/Johnson&Johnson the vaccination certificate is valid from the 22nd day after the vaccination was received. In the case of persons who have recovered and only receive one dose, the vaccination certificate is valid immediately from the date of the vaccination.  
The vaccination certificate is valid for 270 days.  
Proof of vaccination certificate, vaccination card or the digital green passport
- **Proof of recovery** through separation notice, antigen test or proof of recovery status

Please note that the tests have to be renewed after the respective validity has expired.  
Valid access tests are also required in all restaurants, cafés and bars.

**PCR tests** can be carried out in the nearby Novogenia laboratory at Grazbachgasse 54, 8010 Graz. You will usually receive test results within 24 hours. **Antigen tests** are carried out in pharmacies and the test streets of the City of Graz. The closest test street is directly opposite the main train station in Graz at Bahnhofgürtel 85–89, 8020 Graz. The closest pharmacy is the pharmacy Zum Goldenen Engel, Griesgasse 12, 8020 Graz. The result is usually available within 15 minutes. **Self-tests** are available in drug stores and pharmacies. The result is available within 15 minutes.
